

Employers Who Match Charitable Gifts

Many corporations feel a sense of responsibility to give back to the communities in which they do business. The following corporations have either direct giving programs, foundations, sponsorship programs, in-kind donations, product donations, volunteer programs, or matching gift programs.

The main idea of corporate matching gift programs is easy. When an employee has a personal connection to a non profit because of a life experience, the corporation wants to show it's support. Here's how it works:

If you donate \$100 to a non profit organization:

- Go to your HR Department
- Ask for a Matching Gift Form
- Complete and submit it to the appropriate personnel or intranet site at your place of work.
- The employer will then validate the donation and organization, and will send a check of the same value (or higher, depending on the company's matching criteria - some match 2:1 or higher).
